

WAIVER, RELEASE and HOLD HARMLESS AGREEMENT

NLC Love City Community Development Corporation, Inc. ("NLC Love City CDC")

In consideration of permission granted by NLC Love City Community Development Corporation, Inc. ("NLC Love City CDC") allowing _____ ("Camper") to voluntarily participate in the NLC Love City Camp Activities (the "Activity"), which shall occur in Houston, Texas, I represent, covenant and agree, on behalf of myself and my heirs, assigns, any other person claiming by, under or through me, and the Camper, as follows:

General Information

All camp attendees must be no younger than 13 years old and no older than 19 years old. All Campers must always remain in groups of at least two of the same gender to maintain safety. Parents/Legal Guardians will not be permitted to remain on the campgrounds or in any of the buildings unless they are part of the group's registered chaperones.

Chaperones

All Chaperones and Campers will be required to participate in an orientation at NLC Love City CDC as part of the check-in process and all Chaperones must consent to a nationwide background check performed by NLC Love City CDC to complete the registration process.

Medication

NLC Love City CDC's staff and volunteers are not responsible for dispensing or administering any medications (prescription or otherwise). I consent to allowing the above-named Camper to self-administer their prescription medication(s). I agree to place the Camper's prescription medication(s) in a Ziplock bag that is properly labeled with the Camper's name. The Ziplock bag containing the medication(s) must be given to the Camper's assigned Chaperone during the check-in process. I acknowledge it is the Camper's responsibility to appropriately self-administer the medication(s) as prescribed. The Camper agrees not to share medications with other Campers.

Lodging

The NLC Love City CDC dormitories are separated by gender into boy's dormitories and girl's dormitories. The respective dormitories are in two separate buildings to ensure the safety of all the Campers. The NLC Love City CDC dormitories are a bunkhouse-style layout with multiple bunk beds in one area to fulfill the vision of

fellowship and fun. Therefore, the NLC Love City CDC lodging accommodations are shared spaces with other Campers and Chaperones. All dorms also have showers and restrooms.

Damaged or Lost Property

Parents/Legal Guardians understand and hereby acknowledge that NLC Love City CDC, its directors, employees, contractors, agents and volunteers, are not and will not be responsible or liable for any damage, theft, casualty, loss, or destruction involving any personal property.

Indemnification

Parents/Legal Guardians agree to indemnify and hold harmless NLC Love City CDC, New Light Church and each of their respective affiliates, directors, officers, employees, agents, and principals (collectively, NLC Love City CDC Indemnitees and individually, a Love City Indemnitee) from and against all liabilities, losses, claims, demands, damages, costs and expenses (including but not limited to reasonable legal fees and disbursements) suffered or incurred by any NLC Love City CDC Indemnitee and arising as a direct or indirect result of any claim, proceeding, civil, criminal or administrative action, inquiry, suit or legal action instituted against a NLC Love City CDC Indemnitee in respect of the camp activities or the Camper's use of the services and facilities of NLC Love City CDC. Such indemnity shall not apply to the extent that a NLC Love City CDC Indemnitee is claiming indemnity for its own negligence or willful misconduct.

I acknowledge that participating in the Activity involves certain risks (some of which I may not fully appreciate) and that injuries, death, property damage or other harm could occur to the Camper or others. I accept and voluntarily incur all risks of any injuries, damages, or harm which arise during or result from my the Camper's participation in the Activity, including any associated travel, regardless of whether or not caused in whole or in part by the negligence or other fault of NLC Love City CDC or New Light Church, their respective predecessors, successors, assigns, subsidiaries, legal representatives and its former, present and future agents, employees, insurers, Directors and Officers ("Released Parties").

I waive all claims against any of the Released Parties for any injuries, damages, losses or claims, whether known and unknown, which arise during or result from the participation in the Activity, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties. I release and forever discharge the Released Parties from all such claims.

Release:

Parents/Legal Guardians, and on behalf of Camper, hereby release, remise and forever discharge NLC Love City CDC, its affiliates, and their respective agents, directors, employees, suppliers, and all other related associated, or connected persons from any and all manner of rights, claims, complaints, demands, causes of action, proceedings, liabilities, obligations, legal fees, costs, and disbursements of any nature and kind whatsoever arising, whether known or unknown, which now or hereafter exist, which arise from, or relate to, or are connected with the use of NLC Love City CDC's property. P a r e n t / L e g a l G u a r d i a n hereby agree that Parent/Legal Guardian, and on behalf of Camper, will not pursue any legal action against NLC Love City CDC or otherwise make a claim against NLC Love City CDC for any loss, accident, expense, damage, claim, warranty, injury, or similar loss, including death, caused or incurred as a result of Camper's use of NLC Love City CDC's properties.

I expressly agree that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. This Waiver, Release and Hold Harmless Agreement shall be governed by the laws of the State of Texas.

Consent. By the voluntary participation in the Activities, Camper hereby consent to be photographed and/or recorded by NLC Love City CDC and/or its licensees, designees and/or assignees. I irrevocable grant permission to include Camper's likeness, mannerisms and/or voice in any such production or other works, and any and all derivative works thereof, and any and all promotional and advertising materials of such productions or other works (without compensation and/or credit), and further for such productions and other materials containing Camper's image, likeness, voice or mannerisms to be exploited in any and all media worldwide in perpetuity.

I have carefully read and reviewed this Waiver, Release and Hold Harmless Agreement. I understand it fully and I execute it voluntarily.
